POOL & SPA RULES & REGULATIONS

The Pool, Spa, and Wellness Center rules are designed to protect the rights and privileges of all Members and guests, to enhance the safety of all, and to safeguard our Club's property. We ask all Members, guests and employees to abide by the following rules.

◆ **USE OF THE POOL AND SPA AT ANY TIME IS AT THE SWIMMERS' OWN RISK.**

No Life Guards are on duty. Any injuries or accidents should be reported immediately.

◆ Shower before using the pool or spa.

◆ No Diving. Jumping into the pool or spa from the pool deck is strictly prohibited.

◆ Running, pushing, dunking, and tag games are not allowed in the pool, pool area, or spa.

◆ Hours of use for pool and spa are from dawn to dusk – NO nighttime swimming.

(Hours may be changed at the discretion of management as needed for events, repairs, etc.)

◆ Only Members and their guests may use the pool & spa facilities. Unaccompanied Guests must be registered and must be in possession of a Guest Card. Members are responsible for the behavior of their guest.

◆ Children under 12 years of age must be accompanied by an adult. Children not toilet trained must be wearing approved waterproof pants over a swimming diaper while in the pool or spa. Children wearing diapers are not permitted in the pool or spa.

◆ Flotation devices, small pool toys, noodles, water aerobics apparatus, etc. may be permitted depending on the number of persons in the pool so long as they are used in a courteous manner. Masks and snorkels are permitted in the pool.

◆ Throwing of soft material balls or similar objects is permitted away from the proximity of other members in the pool as long as such activity does not to interfere with the enjoyment of the pool and pool deck by other members and guests. Staff is given the full authority and discretion to monitor and/or prohibit such activities in the pool and spa area as necessary.

SPA:

- ◆ Maximum time for spa use is 15 minutes. The spa contains hot, chemically treated water that may be harmful to clothing, skin and health. Follow spa rules and use at own risk.
- ◆ Maximum water temperature in spa is 104 degrees Fahrenheit.
- ◆ People with certain medical conditions should consult a doctor before using the pool or spa.
- ◆ Pregnant women, small children, people with health problems, and people using alcohol, narcotics, or other drugs that cause drowsiness, should not use spa without first consulting a doctor.

GENERAL:

- ◆ No animals (pets) are allowed within the fenced pool area.
- ◆ No bicycles, skateboards, rollerblades or similar items are allowed within the fenced pool area.
- ◆ No glass containers of any kind or objects with sharp edges are allowed within the fenced pool area.
- ◆ Trash should be placed in proper containers located in the pool area.
- ◆ Only food and beverages purchased at the Club may be brought into the pool area.
- ◆ Food and beverages may not be consumed in the pool or spa.
- ◆ Audio devices must be used with ear buds or headphones and must be played at a sound level which is not offensive to other people.
- ◆ All persons using the pool furniture are required to cover the furniture with a towel when using suntan oils or lotions.
- ◆ Persons with open sores, cuts, or contagious diseases are not permitted to use the pool or spa.
- ◆ Smoking is prohibited in the pool and spa.
- ◆ Saving of chairs for persons absent from the pool area is prohibited. Members and guests who leave the pool area for over thirty (30) minutes must relinquish lounges and chairs by removing all towels and personal belongings.

- ◆ Belongings left unattended at any time are done so at the owners' risk. Unattended items may be removed by staff and may be discarded by the Club if not promptly claimed.
- ◆ All activities, including cell phone use, should be conducted in a reasonable manner and one which is not a nuisance or disturbance to others.
- ◆ Pool parties must be authorized by Club management prior to the occasion. Arrangements should be made before inviting guests to ensure that accommodations are available.
- ◆ Club staff is required to enforce these Rules and any infractions should be reported to the Wellness Center Reception Desk. Club staff has the authority to expel from the pool area anyone who fails to cooperate in following the Pool & Spa Rules or whose conduct is otherwise unbecoming of a Member or guest.
